## ADDENDUM NUMBER ONE – YORK COMMONS PARK

## TO INTERGOVERNMENTAL AGREEMENT BETWEEN THE CITY OF ELMHURST AND THE ELMHURST PARK DISTRICT FOR THE CONSTRUCTION OF STORMWATER IMPROVEMENTS

THIS ADDENDUM, NUMBER ONE - YORK COMMONS PARK, TO
INTERGOVERNMENTAL AGREEMENT, entered into this day of
, 2015, by and between the CITY OF ELMHURST, ILLINOIS, a
Illinois municipal corporation, with offices at 209 N. York Street, Elmhurst, DuPage County
Illinois (hereinafter referred to as "CITY"), and the ELMHURST PARK DISTRICT with office
at 375 W. 1st Street, Elmhurst, DuPage County, Illinois (hereinafter referred to as "DISTRICT"
(hereinafter the "Agreement") concerning the construction of certain stormwater and/o
recreational improvements, as more fully described herein:

WHEREAS, the CITY agrees to design, build and construct certain Public Improvements at the CITY's cost pursuant to the terms and conditions of the Agreement at the PARK owned by the DISTRICT commonly known as "York Commons Park"; and

WHEREAS, the Public Improvements to be constructed by the CITY at the PARK include certain Stormwater Improvements depicted in  $\mathbf{Exhibit} - \mathbf{x}$  that is attached hereto and incorporated herein; and

WHEREAS, the Stormwater Improvements to be constructed by the CITY at the PARK shall be maintained in accordance with the "Dry Detention Pond Performance Standards" that are set forth in  $\mathbf{Exhibit} - \mathbf{x}$  that is attached hereto and incorporated herein; and

WHEREAS, the Public Improvements to be constructed by the CITY at the PARK include certain Recreational Improvements depicted in  $\mathbf{Exhibit} - \mathbf{x}$  that is attached hereto and incorporated herein; and

WHEREAS, the Public Improvements to be constructed by the CITY at the PARK are to

be constructed according to the Schedule of Construction that is attached hereto as  $\mathbf{Exhibit} - \mathbf{x}$ 

and incorporated herein; and

WHEREAS, the DISTRICT agrees that it shall grant the CITY easement rights in the

PARK in the form attached hereto as **Exhibit** – **x** which the DISTRICT will sign and forward to

the CITY and the CITY will record at its expense; and

NOW THEREFORE, in consideration of the mutual covenants, conditions and

agreements set forth herein as well as those set forth in the Agreement to which this Addendum

is attached, the parties hereto agree as follows:

1. <u>Incorporation</u>. The provisions set forth in the preamble are incorporated into and

made a part of this Addendum, Number One - York Commons Park, to

Intergovernmental Agreement between the City of Elmhurst and Elmhurst Park

District for the Construction of Stormwater Improvements.

2. <u>Performance of Addendum.</u> The parties agree that the rights and obligations of the

parties to perform the terms of this Addendum are to be undertaken pursuant to the

terms and conditions of the Agreement, which are incorporated herein by reference.

IN WITNESS WHEREOF, the parties have caused this Addendum, Number One –

York Commons Park, to Intergovernmental Agreement between the City of Elmhurst and

Elmhurst Park District for the Construction of Stormwater Improvements, to be executed on their

behalf by their duly authorized officers as of the day and year first above written.
