RE: BUS TRANSPORTATION SERVICES FOR SUMMER CAMP 2024

ISSUE

Staff proposes contracting with Westway Coach, Inc. to provide transportation to field trips for program participants in Funseekers Camps at Eldridge Park and Wagner Community Center, and Camp Canteen at the Wagner Community Center. As staff continues to expand camp offerings, the cost of services, including transportation to field trips increases. To receive the best possible service and price, a sealed bidding process for transportation services was conducted.

DISCUSSION

As part of the bidding process, a legal notice was placed in the Suburban Life on March 15, 2024, to solicit bids. Bid packets were sent to ten contractors. Four contractors returned proposals. Westway Coach submitted the lowest, most responsible proposal of \$32,200.

Westway Coach is one of 15 operating companies that are wholly owned subsidiaries of Cook-Illinois Corporation. Cook-Illinois operates over 2,200 school buses in and around the Chicago area. All vehicles are equipped with two-way radios and GPS tracking systems. All drivers receive a minimum of 50 hours of special training. Participants can speak to a live person 24 hours a day, 7-days a week as needed. A scope review was conducted with Westway Coach staff, and references have been checked, including several school districts.

Funds for transportation were budgeted in the FY 2024 budget in the Recreation Fund. Attached is the bid summary sheet.

RECOMMENDATION

That the Board of Park Commissioners (1) award the Bus Transportation Services for Summer Camp 2024 contract to Westway Coach; and (2) authorize the Executive Director to execute a final contract.
