RE: WASTE REMOVAL & RECYCLING SERVICES 2025 – 2027

## **ISSUE**

The current waste removal and recycling agreement is set to expire on December 31, 2024.

## **DISCUSSION**

Services sought for waste removal and recycling include the provision of 2, 4, 6, and 8-yard trash containers and 2, 4, and 6-yard comingle recycling containers at ten (10) parks located throughout the District.

As a result, plans and specifications were developed and a legal ad was placed in the Elmhurst Suburban Life on March 15, 2024. Bid Packets and specifications were available for pick up at the District's Administrative Office as well as electronically upon request. Bids were opened and read publicly on Friday, April 12, 2024. A copy of the bid tally is attached.

Republic Services made a minor calculation error in the submitted bid documents which was discovered following the bid opening and noted above with an asterisk. Republic did not include annual costs for landscape waste at Plunkett and Wilder Parks. After recalculating totals, Republic Services remains the lowest most responsible bidder.

Staff met with Republic Services sales representative on April 29, 2024 to perform a scope review, discuss expectations and site specific needs as outlined in the original bid documents, and to physically view several container locations. References from the Western Springs Board of Education, Leyden Township School District 212, and Franklin Park School District were all checked to ensure Republic Services has the capacity to support the District's waste hauling needs and could provide the customer support expected from District vendors. Each reference contacted confirmed Republic Services has been able to meet or exceed the expectations of the agreements in place and the Republic Services customer service team has been able to rectify concerns presented by the agency.

## RECOMMENDATION

That the Board of Park Commissioners (1) awards the waste removal and recycling services bid to Republic Services for the term of January 1, 2025 through December 31, 2027; and (2) authorize the Executive Director to execute a final contract with Republic Services.
