ISSUE

Staff will present the proposed 2021 Operating Budget and Tentative Budget & Appropriation Ordinance for review after having previously provided an overview of the proposed 2021 budget, along with the proposed 2021 Capital Budget and Long-range Capital Plan and Debt Service on January 25, 2021.

DISCUSSION

According to Park District Code 70 ILCS 1205/4-4, the adoption of budget and passage of annual appropriation ordinance requires such budget and appropriation ordinance be prepared in tentative form by some person or persons designated by the governing body, and in such tentative form shall be made conveniently available to public inspection for at least 30 days prior to final action thereon. As of February 19, 2021, a copy of each document, Proposed 2021 Budget and Tentative Budget & Appropriation Ordinance, has been made available for public review both on the District's website and at the Administrative Office, 375 W. First Street, Elmhurst, Illinois. A copy of the budget schedule is on the following page.

In addition, to provide transparency to the Board and community, staff will comprehensively present, explain and answer questions regarding the 2021 Proposed Budget and looks forward to responding to the Board's questions.

Elmhurst Park District TENTATIVE ORDINANCE O-XX-21

AN ORDINANCE MAKING A COMBINED ANNUAL BUDGET AND APPROPRIATION OF FUNDS NECESSARY TO DEFRAY ALL NECESSARY EXPENSES AND LIABILITIES OF THE ELMHURST PARK DISTRICT, DUPAGE AND COOK COUNTIES, ILLINOIS, FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2021 AND ENDING DECEMBER 31, 2021 AND SPECIFYING THE OBJECTS AND PURPOSES FOR WHICH SUCH APPROPRIATIONS ARE MADE, AND THE AMOUNT APPROPRIATED FOR EACH OBJECT OR PURPOSE.

WHEREAS, the Board of Park Commissioners of the Elmhurst Park District, DuPage and Cook Counties, Illinois caused to be prepared a combined Budget and Appropriation Ordinance and the Secretary of this Board has made the same conveniently available to public inspection for at least thirty days prior to final action thereon, and

WHEREAS, a public hearing was held as to such Budget and Appropriation Ordinance on the 8th day of March 2021 and notice of said hearing was given at least one week prior thereto as required by law and all other legal requirements have been complied with,

NOW THEREFORE, BE IT ORDAINED by the Board of Park Commissioners of the Elmhurst Park District, DuPage and Cook Counties, Illinois, as follows:

Section 1: A sum of money in the total amount of eighteen million, six hundred and forty-six thousand, three hundred and thirty-one dollars (\$18,646,331) or as much thereof as may be authorized by law, be and the same is hereby budgeted, and that the sum of money in the total amount of twenty-two million, three hundred and seventy-five thousand, and five hundred and ninety-seven dollars (\$22,375,597) or as much thereof as may be authorized by law, be and the same is hereby appropriated for the corporate purposes of the Elmhurst Park District, as herein specified for the fiscal year beginning January 1, 2021 and ending December 31, 2021.

Section 2: The amounts budgeted and appropriated for each purpose are as follows:

<u>Section 3</u>: Pursuant to law, the following determinations have been made and are hereby made a part hereof:

(a) Estimate of cash on hand at the beginning of the fiscal year	\$12,903,909
(b) Estimate of cash expected to be received during the fiscal year from all sources:	\$17,558,131
(c) Estimate of expenditures contemplated for the fiscal year:	(\$18,646,331)

(d) Estimated cash expected to be on hand at the end of the fiscal year:

<u>Section 4</u>: All unexpended balances of the appropriations for the fiscal year ending the 31st day of December 2020 and prior years to the extent not otherwise re-appropriated for other purposes herein are hereby specifically re-appropriated for the same general purposes for which they were originally made and may be expended in making up any insufficiency of any other items provided in this Appropriation Ordinance, pursuant to law.

All receipts and revenue not specifically appropriated shall constitute the General Fund and shall be placed to the credit of such fund.

<u>Section 5</u>: All ordinances or parts of ordinances conflicting with any of the provisions of this Ordinance be and the same are hereby modified or repealed. If any item or portion of this Ordinance is for any reason held invalid, such decision shall not affect the validity of the remaining portion of such item or the remainder of this Ordinance.

<u>Section 6</u>: This Ordinance is not intended or required to be in support of or in relation to any tax levy made by the Park District during the fiscal year beginning January 1, 2021 and ending December 31, 2021, or any other fiscal year.

<u>Section 7</u>: This Ordinance shall be in full force and effect from and after its adoption as provided by law. A certified copy of this Ordinance shall be filed with the County Clerks of DuPage and Cook Counties, Illinois, together with the certificate of the Chief Fiscal Officer of the Park District certifying revenues by source anticipated to be received by the Park District, within thirty (30) days after its passage and approval, as provided by law.
