If the request is denied, you have the right to appeal to the Public Access Counselor with the Attorney General's office ([PublicAccess@atg.state.il.us](mailto:PublicAccess@atg.state.il.us)). \*The District has twenty-one (21) business days to respond to a request for information that is made for a commercial purpose.
