TUITION FEES

Registration in a Sunbeams and Rainbows program is considered school-year enrollment. Three and Four-Year-Old preschool begins September 8/9, 2020 and ends May 13/14, 2021. Class calendars are available online beginning July 15, 2020. Annual tuition may be paid in full or in nine equal installment payments through auto-pay.

Termination of Enrollment:

To terminate enrollment in Sunbeams & Rainbows preschool, a Termination of Enrollment Form must be submitted to the Wagner Community Center by August 1, 2020. After August 1, 2020, a Termination of Enrollment Form must be submitted 30-days in advance of the child's last day of preschool to be eligible for a prorated tuition refund. Registration fees are non-refundable.

REQUIREMENTS

Two-year-old (preschool age) child must be two years old on or before March 15, 2020. Pull-ups are permitted – parent/caregiver must be available to change within fifteen minutes.

Three-year-old (preschool age) child must be three years old on or before September 1, 2020. Four-year-old (pre-kindergarten age) child must be four years old on or before September 1, 2020. Child must be able to use the restroom independently.

You will be required to submit copy of birth certificate, DHS State of IL Certificate of Child Health Examination, a Student Information Form, and an Authorization & Consent Form prior to the first day of class.
